- **Sole Source Contract (Without Competition): NEC Corporation**
 Recommendation to award a contract to NEC Corporation (\$112,326.05) to maintain automated fingerprint identification system without competition was approved.

- **South Fulton Fees Increases Add \$175,000 to 2010 South Fulton SSD Budget**
 Proposed fee increases generating an additional \$175,000 for Fulton SSD were approved. Fees included the following departments: Environment and Community Development Fire Rescue Parks and Recreation and Police. [Click here for more information](#)
- **Grady Outpatient Dialysis Clinic Closing: Financial Data Unavailable**
 A claim by Grady administrators that the Outpatient Dialysis Clinic was “losing millions” when it closed in October 2009 could not be validated by the application of General Accounting Standards according to Fulton County’s Internal Auditor (Anthony Nicks). A discussion of the clinic closing also disclosed that 17 uninsured patients were identified as Fulton County residents and 1 has deceased since the clinic closed.
